

## What is this?



The Zoning By-law Amendments request to rezone portions of the subject lands containing agricultural infrastructure (sewage lagoons and spray fields) to a site-specific "Agricultural Purposes Only (APO) Zone" for those uses with a provision for reduced lot frontage. The applications also propose the APO Zone for an additional parcel to preclude the construction of a new dwelling on the subject lands in perpetuity. The Zoning By-law Amendments are required to fulfill conditions related Consent of applications (Files B-07/22, B-08/22 & B-09/22).

If a person or public body does not share their views in writing to the Town Clerk or orally at a statutory Public Meeting before a decision is made, the person/public body:

- a) Is not entitled to appeal the decision of the Town of Niagara-on-the-Lake to the Ontario Land Tribunal; and
- b) May not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
