A BY-LAW TO AMEND BY-LAW NO. 5190-19 BEING A BY-LAW FOR MAINTAINING LAND IN A CLEAN AND CLEAR CONDITION

WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5190-19 on January 20, 2020;

AND WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5334-21 on June 21, 2021;

AND WHEREAS The Town of Niagara-on-the-Lake considers it desirable to have one administrative penalty system for all non-parking related offences;

NOW THEREFORE the Council of The Corporation of The Town of Niagara-on-the-Lake enacts as follows:

- 1. That By-law No. 5190-19 be amended by adding Schedule "A" attached hereto.
- 2. That By-law No. 5190-19 be amended by adding Section 5.3 as follows:
 - 5.3 Any person who contravenes this By-law may be issued an administrative penalty in accordance with the AMPS By-law 5334-21 for Non-Parking Offences in accordance with Schedule "A," attached hereto and forming part of this By-law
- 3. That By-law No. 5190-19 be amended by renumbering the following Section ADMINISTRATION AND ENFORCEMENT

- 5.4 By-law No. 4114-07 is hereby repealed.
- 5.5 This by-law shall come into force and take effect on the passing thereof.
- 4. That this by-law shall come into force and effect immediately upon the passing thereof.
