# **BY-LAW NO. 4588A-21**

A BY-LAW TO AMEND BY-LAW NO. 4588-12 TO PROHIBIT AND REGULATE NOISE IN THE TOWN OF NIAGARA-ON-THE-LAKE

WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 4588-12 on October 9, 2012;

**AND WHEREAS** the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5334-21 on June 21, 2021;

**AND WHEREAS** The Town of Niagara-on-the-Lake considers it desirable to have one administrative penalty system for all non-parking related offences;

**NOW THEREFORE** the Council of The Corporation of The Town of Niagara-on-the-Lake enacts as follows:

- 1. That By-law No. 4588-12 be amended by deleting Part I Provincial Offences Act Schedule Short Title Fines.
- 2. That By-law No. 4588-12 be amended by adding Schedule "C" attached hereto.
- 3. That By-law No. 4588-12 be amended by adding Section 30 as follows:
  - 30. Any person who contravenes this By-law may be issued an administrative penalty in accordance with the AMPS By-law 5334-21 for Non-Parking Offences in accordance with Schedule "D," attached hereto and forming part of this By-law
- 4. That By-law No. 4588-12 be amended by renumbering Sections 30 and 31 as follows:

## **Enactment**

- 31. By-law No. 2353-91, as amended, is hereby repealed.
- 32. This By-law comes into force and effect on the date of its passing and enactment.
- 5. That this by-law come info force and effect immediately upon the passing thereof.
