Guest Code of Conduct –

(For Patrons and their guests)

[Club Name] is a private, members-only club that welcomes guests in accordance with club policies. To ensure a respectful, safe, and enjoyable environment for all members, guests, and our surrounding residential community, all visitors must adhere to the following **Guest Code of Conduct**. The capitalized words “Patron”, “Member” and “Guest” have the meanings as defined in Operating Agreement between The Scotsman Hotel and Town of Niagara-on-the-Lake, and include their respective guests where otherwise permitted.

1. Club premises

Patrons) must always remain within the licensed premises while attending the Club, which includes:

- ground floor common areas
- exterior back patio area

Prohibited areas include:

- stairwells
- Scotsman Hotel guest room areas on first and second floors, which are exclusively for guests of the Scotsman Hotel
- any other areas posted as restricted or private.

2. Respect for the Residential Community

[Club Name] is located in a residential neighborhood, and we are committed to being good neighbors. Guests must conduct themselves in a manner that does not disturb area residents.

Prohibited behaviors include but are not limited to:

- Loud music indoors or outdoors.
- Public intoxication.
- Parking vehicles contrary to the terms outlined in s. 4
- Any conduct likely to disturb the peace, rest, or enjoyment of neighboring residents.

Please note the Town of Niagara-on-the-Lake Noise By-law No. 4588-12, as amended, is in effect. **Violations may result in removal from the premises by staff, and/or other actions taken by local authorities.**

2. Alcohol Consumption & Responsible Behavior

- Patrons must comply with all applicable laws and club policies regarding the responsible consumption of alcohol.
- Overconsumption, intoxicated behavior, or any conduct that is disruptive, unsafe, or disrespectful to members, staff, or neighbors will not be tolerated.
- Patrons must not leave the premises with open alcohol containers.
- Any Patrons who appears intoxicated or disruptive may be asked to leave.

3. Gatherings & Private Events

- Members are responsible for ensuring that their guests behave respectfully and in accordance with this Code of Conduct.
- Large gatherings, celebrations, or private events must be approved by club management in advance.
- Commercial events, unauthorized parties, or "party house" behavior are strictly prohibited.

4. Parking & Transportation

- Walking, ride-sharing, carpooling, and other forms of transportation and transit are encouraged to minimize traffic congestion in the neighbourhood.
- Members must not block driveways, sidewalks, or access to neighbouring properties.
- Patrons must park only in designated areas and comply with the club's parking plan, which is available from management. Parking arrangements should be considered in advance of visiting the club.

5. Compliance & Enforcement

- Members are responsible for their guests' compliance with this Code of Conduct.
- Any Patron or guest who violates club policies, local by-laws, or engages in disruptive behavior may be asked to leave immediately and may be permanently banned from the club at the sole discretion of management.
- Repeated violations by a Member or their guest may result in revocation of privileges for the Member.

- Members acknowledge the privilege of club membership is at the sole discretion of the Scotsman; any individual's membership may be revoked, suspended, or be made subject to conditions at any time for any legally permissible reason, including non-compliance with this Code of Conduct
