### NOTES:

As a condition of the M.O.E. Permit to Take Water, the Town is required to obtain daily water taking records from all municipal permit holders.

This form is provided for your convenience in maintaining accurate records, the purpose of which is to record details and information about all takings of water from the municipal irrigation system.

### **INSTRUCTIONS:**

- 1. Use a separate form for each pump (water taking location).
- 2. To obtain the total (column 6), multiply rate of taking (column 4) X total hours (column 3) X 60 (minutes per hour) (eg. 200 x 14 x 60 = 168,000). This provides the total amount of taking in gallons or litres per day.
- 3. This form must be submitted no later than seven (7) days following each calendar month.
