We are pleased to introduce **eSend**, a new electronic service that will be effective for the **2016 taxation year**.

Now you can receive your property tax bill and notices from us via e-mail. It's easy. Simply click on the **Property Taxes** button at <a href="https://www.notl.com">www.notl.com</a> and sign up for the **eSend** program. Please include one e-mail address per property. Beginning next February, we will send your property tax bill electronically.

## **CONVENIENT PAYMENT METHODS**

Don't forget we also offer convenient and reliable methods to pay your property tax bill, saving you time and money. For more information on all these programs, please click the **Property Taxes** button on our website homepage at <a href="https://www.notl.org">www.notl.org</a>.

**Pre-Authorized Payment Plan (PAPP) –** PAPPs are automatically deducted from your bank account. This method avoids postage, line-ups, due dates and paper cheques. You can do either monthly or installment payment plans. PAPP is the easiest and most popular alternative form of payment available because if you choose the monthly PAPP option, the burden of property taxes is spread over 12 months instead of 4 installments.

**Online Banking –** With this method you pay through your financial institution's website, avoiding postage, line-ups and paper cheques, with the added benefit of being able to pay anywhere with an internet connection (even on your smartphone). Using your 19-digit property roll number for the account, you can easily set up the Town of Niagara-on-the-Lake as a payee with your financial institution and you're ready to make payments.

**Telephone Banking** – Use your telephone to call a bill payment phone number provided by your financial institution. This method provides many of the same benefits provided by online banking.

**Paymentus (Online & Telephone) –** This method uses a payment service to provide online and telephone options for paying with your credit card. Accepted credit cards are Visa and MasterCard. Please note that service charges will apply when making payments using Paymentus.
