**A BY-LAW TO AMEND BY-LAW NO. 4512B-22 OF THE  
CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE  
RESPECTING ANIMAL CARE AND CONTROL**

**WHEREAS** the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 4512-11 on December 12, 2011;

**AND WHEREAS** the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5334-21 on June 21, 2021;

**AND WHEREAS** the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 4512B-22 on February 28, 2022;

**AND WHEREAS** Council adopted the recommendations contained in Corporate Services Report CAO-22-001 to approve an amendment to the by-law to address wildlife feeding.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE ENACTS AS FOLLOWS:

1. That Schedule "C" attached to By-law No. 4512B-22 be deleted and replaced with Schedule "C" attached hereto;
2. That this by-law come into force and effect upon the passing thereof.
