Town Launches Official Plan Review

It has been almost 20 years since the Town of Niagara-on-the-Lake revised its Official Plan. Many things have changed since then and we want you to be a part of deciding how our community will look 20 years from now.

Many of you have already helped kick-start this process by participating in last year's *Community Vision* project. Following several open houses, workshops and focus

group sessions, we took all of your ideas and directions and developed a Community Vision Statement, eight key priorities and corresponding strategies to reach them.

But this is just a start. Beginning February 2014, we will release a series of issue papers outlining ways we can make our community even more prosperous, healthy, and integrated.

What Is An Official Plan?

An Official Plan is a blueprint for how our community will grow. That's why we want to hear from you as this process unfolds over the next two years. You are Niagara-on-the-Lake and this is YOUR plan, YOUR future.

Why Are We Doing This?

Using input you provided during the *Community Vision* project, we are proposing a game plan of how to design our community that meets the needs of our residents and provides a structure for sustainable growth.

So, why do this now?

The *Ontario Planning Act* sets out review requirements for every municipality to follow. While we have undertaken a number of secondary plan

amendments over the years, we must conduct a full review to comply with update provisions under the Act.

More importantly, the Act requires that all municipal by-laws and projects relating to land-use planning be consistent with the Official Plan.

The eight strategic priorities identified from last year's *Community Vision* project will now be incorporated into a series of issue papers. The first paper was released for comment in February 2014.

The remaining papers will be released throughout 2014 and 2015, accompanied by a public open house for each.

We have created a special page on the Town's website specifically for discussion of the Official Plan, including ways in which you can provide your feedback to us.

Also, we hope to engage you through the marvels of social media, by keeping you informed of each step of this progression.

By the Fall of 2015, we should have a draft Official Plan to present to you, followed by a request for formal approval through Niagara Region.
