INDEPENDENT AUDITOR'S REPORT

To Gary Burroughs and the Town of Niagara-on-the-Lake,

Qualified Opinion

We have audited the Auditor's Report Candidate - Form 4 of Gary Burroughs (the Candidate), which comprises the Form 4 statement of campaign income and expenses, a calculation of surplus or deficit, and other relevant supporting schedules as per the Municipal Elections Act, 1996 (Section 88).

In our opinion, except for the possible effects of the matter described in the *Basis for Qualified Opinion* section of our report, the accompanying Form 4 is prepared fairly, in all material respects, in accordance with the financial reporting provisions of the Municipal Elections Act, 1996 (Section 88).

Basis for Qualified Opinion

The Candidate derives revenue from campaign contributions, the completeness of which is not susceptible of satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Candidate and we were not able to determine whether any adjustments might be necessary to contributions, and calculation of surplus or deficit for the period ending December 31, 2022

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the* Form 4 section of our report. We are independent of the Candidate in accordance with the ethical requirements that are relevant to our audit of the form 4 report in Canada, and we have fulfilled our other ethical responsibilities in accordance with those requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Emphasis of Matter - Financial Reporting Framework and Restriction on Use

Without modifying our opinion, we draw attention to the fact that the Form 4 has been prepared in accordance with the reporting provisions of the Municipal Elections Act, 1996 (Section 88). As a result, our report and Form 4 should not be used by any parties other than the Candidate and the Town of Niagara-on-the-Lake.

Other Information

Our opinion on the Form 4 does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Form 4, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Form 4 or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Responsibilities of the Candidate for the Form 4 Report

Management is responsible for the preparation and fair presentation of the Form 4 in accordance with Municipal Elections Act, 1996 (Section 88), and for such internal control as management determines is necessary to enable the preparation of the Form 4 that are free from material misstatement, whether due to fraud or error.

In preparing the Form 4, the Candidate is responsible for assessing the ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Candidate is responsible for overseeing the financial reporting process; including determining that the applicable financial reporting framework is an acceptable basis for the prepartion of the Form 4 Report.

Auditor's Responsibilities for the Audit of the Form 4 Report

Our objectives are to obtain reasonable assurance about whether the Form 4 as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the Form 4. As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the Form 4, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures
 that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
 effectiveness of the Candidate's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Evaluate the overall presentation, structure and content of the Form 4, including the disclosures, and whether the Form 4 report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the Candidate regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
